Company Reports

5.1 Qenos EMT report

Andrew updated members on Qenos since November 2016.

PFAS Risk Assessment Process

- Qenos reported the discovery of PFAS in groundwater to EPA in December and proposed to complete a PFAS risk assessment.
- EPA issued a Clean Up notice to Qenos in December 2016 to complete the Risk assessment and to have an EPA appointed auditor verify a clean-up plan.
- PFAS is a component of firefighting foam. Qenos is phasing out.
- PFAS, although not proven, may have health links about which there is some concern
- Remediation of soil or groundwater is problematic .Approved method is high temperature incineration however this process not available yet in Australia. The EPAS are working together to develop approved waste outlets by year end.
- Qenos Environment specialist company AECOM is conducting risk assessment, to be completed by 31 Aug 17, with Clean Up Plan to be developed by March 2018
- Will discuss findings with Auditor in May and with EPA in June.
- On schedule as per EPA request
- Qenos attended PFAS summit in April run by Heads of EPA who are trying to implement a national strategy.

- Odour audit conducted in April, report being prepared for distribution
 Qenos attended Biodiversity Strategy meeting at Council in April with the intention to coordinate weed and pest activities within the Hobsons Bay area, unified process.
- No complaints, community not affected by shutdown

- In discussion with Qenos regarding Resins renewal of trade waste licence, due to expire on 31 May 2017
- Olefins plant currently meeting requirements, non detection of sulphide breaches from onsite visit early 2017
- Approved trial for the use of Amerscent 50 (deodoriser) for sewer odour treatment, on an as needs basis.
