# **Company Reports**

## 5.1 Dow EMT report

KC updated the members as follows:

- Safety Case submitted in October. More than 5,000 hours invested into safety case since early 2017
- Emergency plan conducted with MFB, Vic Police and Hobsons Bay Council in mid September 2017
- Worksafe follow up visit scheduled for January 2018
- No injuries since May 2016
- No recordable containment loss since August 2015

#### **EPA**

Major industries assessment carried out in September 2016 and day after received remedial notice to conduct further review on emissions.

#### **CWW**

Compliant with current trade waste agreement. All trade waste licences prepared end of month, less variations to their licence.

#### WorkSafe

No reportable events 4 visits to plant

#### **EH & S Improvement Plan**

Upgrade to boom lift with automated horn Improved spill protection at three bulk loading stations Replacement of pumps on bulk storage tanks

#### 2018 Key Project

Aim to achieve 99% destruction efficiency with incineration to route process vents that will not impact on current EPA licence

Project to commence in February 2018

Cr Sandra Wilson asked whether the groundwater being tested on various sites in Altona P-9 College presented any visible sightings to be concerned about.

Andrew Lake responded that they'd need to check with the college however there was a lot of interaction with the community. There were letter drops and notifications on the website. There were no direct queries. Cr Sandra Wilson questioned what would elicit a response.

## 5.2 Qenos EMT report

Andrew updated members on Qenos since May 2017.

#### **Community Engagement**

- Joint August EMT meeting held at DOW.
- 3 complaints. One complaint on 22<sup>nd</sup> September due to unplanned shutdown (maintenance cleaning) on SCAL1 off spec, this was unavoidable. Two complaints on 1<sup>st</sup> October regarding flare size, noise and large glow in cloud due to low cloud coverage. Flaring was from SCAL2 off spec due to a fuel gas upset. The fuel gas system tuning has been modified to reduce the risk of a recurrence.

#### Minutes 2 November 2017

• Attended Council Municipal Emergency Response drill on 30<sup>th</sup> October. Many different views amongst authorities. Shelter and placement in relation to evacuation discussed, police stated they do not have enough resources to evacuate everyone in the case of an emergency evacuation.

### **Regulatory Interface**

- EPA site assessment on historical firefighting foam use impact submitted in Aug 2017 with clean up plan to be submitted in March 2018
- New EPA officer visited Qenos on 25<sup>th</sup> October to become familiar with site
- Noise environment improvement plan progress report was submitted in August CWW No current issues. Olefins trade waste licence due for renewal early 2018
- Worksafe Fourth safety case submitted. At present only received verbal notification of approval for 5 year licence.

#### 2017 Reflection

- Not achieving level of performance desired from organisations' leaders, contractors, employees, still opportunity to improve risk identification and hazard awareness
- Performance indictors significant progress
- Environmental Management System update for ISO-14001 Progressing well for 2018 accreditation
- Shutdown of Lummus furnace completed, community noise being monitored, and Charles Road data looks good, Galvin St Data variable, further investigation required.
- Planned shut down in Jan/Feb completed with no complaints or compliance issues, good
- Ongoing challenges with natural gas and high energy costs
- Electricity and gas crisis business challenge for Qenos
- Product development Less material used for new milk bottle product, light weight
- 'No Dig' strategy Case study on website. Good outcome in product development, more cost effective trenchless installation with less erosion and pipe maintenance.

Chris Rider asked how they planned to overcome their gas issue. Andrew Lake responded: Reduce costs, improve revenue, new products, reorganising workflow

#### **2018 Focus**

- SHE performance Continue emphasis on leadership and development
- Business outlook Planned maintenance work in March/April 2018
- Product development product release of new milk bottle
- Andrew Lake commented on Operation Clean Sweep A number of projects are
  progressing to improve containment of 'polyethylene fluff and pellets Plastics site. Team
  working on new design and extra protection to prevent PE pellets on trucks leaving
  worksite. Cr Sandra Wilson noted Beach Patrol was collecting plastics.

In regards to the recent flaring, Chris Rider stated that the flare was more noticeable due to low cloud that evening. Chris also commented that his neighbour was worried and quite panicky and noted that no-one seems to know the environmental hotline. Chris also commented that companies should do more than only distribute letter drops as too much junk mail is being received and may be missed by residents.

# 6. Hobsons Bay City Council report

Brendan Murphy updated members on relevant Planning Applications.

- Innovia site and soil remediation facility highly contested, Innovia on-sold to EnviroPacific and there has been construction taking place since February 2016.
- Unsure of completion time, 85% complete, occupancy certificate should be issued prior to Christmas.

#### Minutes 2 November 2017

- Old BASF site no applications to HBCC. BASF still lander holders, caveat held since late 1950's for petrol chemical use. Purpose of caveat – needs to be compatible with surrounding industries.
- Multiple petrol stations questioned, all based on individual merits.
