Major Components



HydroTip: -Beginning of the soil receival process

-Vibrating screen that shall remove oversized material (+5mm) before discharging the remaining contents of the drill mud to the next step.



EvoWash:

Removes sand through use of a hydro cyclone, a device that uses gravitational forces to separate particles from water.

 Remaining product (0-0.063mm) moves through a buffer tank.



AquaCycle A200:

- The water is then pumped to a DAF clarify the water.
- This system removes oils and solids.



Centrifuge:

- The water (and remaining sediment) is pumped into a centrifuge which further separates solid and liquid.
